### **NEW CBSE BYELAWS were discussed**

Few points from CBSE and NCERT were also discussed.

- Homeworks should not be assigned to the students of class I & II
- Subjects like Maths & Language only to be taught to classes I & II and EVS, Maths and Lang for classes III to V as prescribed by the NCERT
- GK / Moral Science, art and computer science can come under life skill which will not be tested.
- Adequate measures to be taken to reduce school bag weight as per norms
- In-service Training for 3 days must for teachers.
- Training Certificate to be produced
- 3 days training must from (COE) or any teacher training Institute from Central / State approved organization

### **EXTENSION OF AFFILIATION**

- School should have separate entrance Board for state board building
- All constructional sites behind school building should be completed, compound wall to be rebuilt
- It is mandatory to have special educator/ student counsellor / physical educators to be appointed in the ratio 1:500
- Documents like sanitation, school building safety certificate, transport certificate, property tax certificate, water quality check certificate and fire certificate should be intact.
- All resident school to be kept separate
